⁶Under the contingent offer approach, the Program requires additional time to process returned offer packages while it determines the availability of funding, meaning the Bureau of Indian Affairs Acquisition Center will generally start approving offers 46 days after the cover letter date. As a result, locations mailed after October 2020 might not reflect approved offer data until that time.
