Decommissioning

The Bloomberg Fixed Income Index Family indices represented in Table 1 are scheduled for full deprecation on December 31, 2020. A business decision was made to retire the legacy Bloomberg Bond Index family (GFI) based on overlap with the Bloomberg Barclays index family and the cost of maintaining more than one index platform.

Suitable replacements for the Bloomberg legacy indices may be found within the Bloomberg Barclays index family that spans 70,000+ securities with over \$50tn MV representing 110 countries and 39 local currency debt markets and aligns with global standards.

Where Bloomberg has identified a replacement it has been included in Tabel 1 and is listed on the DES page. For those where there is no recommendation you can find more Bloomberg Barclays offerings by visiting the Bloomberg Barclays Index Browser, IN <GO>.
